History

On February 28, 1867, "The Town of Red Bud" was chartered. In 2023 we marked the city's 156th anniversary.

- Ratz Park Revitalization Project bids were due October 4. Single bid was denied. Project was rebid on December 14. Bids due January 26, 2024. Project completion date of September 13, 2024. Grant timeframe of October 2022 to September 30, 2024.
- Lincoln Park expansion via donation completed in May
- Red Bud Business Park Name was chosen for the complex. Streets have been named. Lot pricing, funding and scope discussed December 18.
- Police Department equipment 1) LPR's were approved November 7, 2022. Vehicle LPR installed, others pending. 2) Durango arrived and on September 8 was transferred to Datatronics for equipment, awaiting completion. 3) Radar trailer is on order. 4) Body and incar cameras have arrived. In-car cameras are awaiting installation.
- City Hall building repairs and maintenance Awaiting Quadrant to provide bid specs.
- Comprehensive plan for the city's future Project moves forward in 2024 with an estimated 12-18 month completion.

* Electricity - The City of Red Bud continues to be a member of the Illinois Municipal Electric Agency. We maintain our own local power generation plant which is utilized when called upon. The 2023 annual average price statewide through November for electric sold to residential customers was 16.05 cents (no taxes or fees). The City of Red Bud's 2023 average price of electric sold to residential customers was 11.72 cents per kWh (no taxes or fees).

* Gas – June 19 - The City of Red Bud transitioned from the purchase of gas from Symmetry Energy Solutions, LLC to Utility Gas Management with an effective date of November 1. Ron Ragan

is engaged and provides regular information on gas markets and what we can do to keep our rates as stable as possible.

* Water and Sewer - The City of Red Bud maintains two wells near the Kaskaskia River. In addition, Red Bud has two water towers – the north tower with a capacity of 500,000 gallons and the south tower with a capacity of 200,000 gallons.

Water Revenue Rate \$5.91 (\$/1,000 gallons) including taxes and fees

A number of measures have been put in place during 2023 to improve the water quality:

January 3 - Promoted from within to hire a Class D Water Operator

Spring – Hydrant flushing

July 10 – Approval to add a new position of Water/Wastewater Technician. August 21 promotion from within.

July 10 – Approval for step increases for additional licensing

September 5 – Approval of chemical treatment of well #1. (note, well #2 was treated in 2022) October – The water aerator was replaced. As of 12/31/2023, final paperwork to be processed. The \$187,000 grant that assisted with this project time frame of March 2, 2022 to February 28, 2024.

The City maintains a sewer processing plant with design flow of 300,000 gallons per day with a max flow of 600,000 gallons per day.

Video Gaming

As of December 2023, there were 71 video gaming terminals in Red Bud. Per the Illinois Gaming Board Video Gaming Report for 2023, funds in were \$10,121,598 with funds out (winnings) of \$7,565,522 for a net of \$2,533,155. The city's share of the video gaming terminal tax was \$127,414 and these dollars are used to help support the various parks in our city.
