ORDINANCE NO. 1455

**AN ORDINANCE ADOPTING AND ENACTING THE
“CITY OF RED BUD CODE OF ORDINANCES 2021”**

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/1-2-3 authorizes the Mayor and City Council to appoint a person to revise the city ordinances; and

WHEREAS, the Mayor and City Council did approve and appoint the City Attorney to review and revise the entire Revised Code of Ordinances; and

WHEREAS, the City Attorney did review and revise the Revised Code of Ordinances which was presented to the Mayor, City Council, and other city officials for review; and

WHEREAS, the Planning Commission held a Public Hearing following due Notice on March 16, 2021 at 7:00 p.m. in the City Hall, 200 E. Market St., Red Bud, Illinois to consider the City’s application to amend the Subdivision and Zoning Codes; and

WHEREAS, the Planning Commission thereafter prepared and submitted its findings of fact and recommendations regarding the amendments to the City Council, a copy of which is attached hereto as “Exhibit A” and incorporated herein; and

WHEREAS, the final new code of ordinances known as the “City of Red Bud Code of Ordinances 2021” is hereby presented for final approval; and

WHEREAS, the City of Red Bud has deemed it in the best interests of the City to adopt and enact the “City of Red Bud Code of Ordinances 2021.”

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

SECTION 1: That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

SECTION 2: That the following shall be the “City of Red Bud Code of Ordinances 2021,” which is attached hereto as “Exhibit B” in an electronic format and incorporated herein by reference as if it were written herein verbatim, containing Chapters 1-175.

SECTION 3: The words of Chapter 1-175 of “Exhibit B” are the enacted portions only and are not restricted to the formatting, style or appearance as presented.

SECTION 4: After passage, the “City of Red Bud Code of Ordinances 2021” shall be codified into a book format, shall have formatting applied for a uniform appearance, and shall be regularly updated.

SECTION 5: After passage, the “City of Red Bud Code of Ordinances 2021” may be changed without further approval if a reference to another section of the Code, statute, regulation, rule, or order is found to be clearly erroneous based upon the last version of the Revised Code of Ordinances in existence prior to this Code.

SECTION 6: This Ordinance shall be in full force and effect on May 1, 2021 after its passage by the City Council, signature by the Mayor, and publication in pamphlet form, as provided by law.
