CITY OF RED BUD IS INVITING SEALED BID PROPOSALS FROM INTERESTED AND QUALIFIED PARTIES FOR A CITY PARK RENOVATION AND SPLASH PAD, LOCATED AT RATZ PARK, 583-737 WEST MARKET ST. RED BUD, ILLINOIS 62278.

THIS PROJECT CONSISTS OF LIMITED DEMOLITION, CONSTRUCTION OF A NEW SPLASH PAD, RESTROOM FACILITY, PLAYGROUND AREAS, VARIOUS PARK SITE IMPROVEMENTS, AND LANDSCAPING.

THIS PROJECT IS BEING FINANCED, IN PART, WITH FUNDS FROM THE ILLINOIS DEPARTMENT OF NATURAL RESOURCES, "OPEN SPACE LANDS ACQUISITION & DEVELOPMENT" (OSLAD) GRANT PROGRAM. BIDDERS MUST BE PROPERLY LICENSED UNDER THE LAWS GOVERNING THEIR RESPECTIVE TRADES AND BE ABLE TO OBTAIN INSURANCE AND BONDS REQUIRED FOR THE WORK. A PERFORMANCE BOND IN THE AMOUNT OF 100% OF THE TOTAL BID, SEPARATE LABOR AND MATERIAL PAYMENT BOND IN THE AMOUNT OF 100% OF THE BID TOTAL, AND INSURANCE IN A FORM ACCEPTABLE TO OWNER WILL BE REQUIRED OF THE SUCCESSFUL BIDDER. THE OWNER REQUIRES ALL CONTRACTORS AND VENDORS DOING BUSINESS WITH THE OWNER NOT TO DISCRIMINATE AGAINST ANYONE ON THE BASIS OF RACE, AGE, COLOR, RELIGION, GENDER, SEXUAL ORIENTATION, ANCESTRY, NON JOB-RELATED HANDICAPS OR NATIONAL ORIGIN. SUCCESSFUL BIDDERS SHALL BE REQUIRED TO OBSERVE THE FAIR EMPLOYMENT PRACTICES COMMISSION RULES PERTAINING TO EQUAL EMPLOYMENT OPPORTUNITY, AND COMPLY WITH THE ILLINOIS PREVAILING WAGE ACT, 820 ILCS 130/1 ET SEQ., AND USE WAGE DETERMINATION AS DETERMINED BY THE ILLINOIS DEPARTMENT OF LABOR, CONCILIATION, AND MEDIATION DIVISION DATED MOST CURRENT. THESE WAGES WILL REMAIN IN EFFECT UNTIL SUPERSEDED BY A NEW DETERMINATION.

BID SECURITY SHALL BE SUBMITTED WITH EACH BID IN THE AMOUNT OF FIVE (5)PERCENT OF THE BID AMOUNT. NO BIDS MAY BE WITH-DRAWN FOR A PERIOD OF 60 DAYS AFTER OPENING OF BIDS.

CITY OF RED BUD RESERVES THE RIGHT TO ACCEPT OR REJECT ANY AND ALL BIDS, AND TO WAIVE ANY AND ALL INFORMALITIES IN THE BIDDING. AFTER RECEIPT OF BIDS AND COMPLETION OF THE REVIEW PROCESS, CITY OF RED BUD MAY AWARD A CONTRACT TO THE BIDDER THAT, IN ITS OPINION, WILL PROVIDE A COMBINATION OF THE BEST SERVICES AND REASONABLE COST. JUSTIFICATION FOR AWARDED THE CONTRACT TO A BIDDING FIRM OTHER THAN THE LOWEST BIDDER IS SUBJECT TO ILLINOIS IDNR APPROVAL.
