#### VII. Correspondence and Public Guest Comments

A. Commander Clarence Nail, VFW Post 6632 VFW Post 6632 Commander Clarence Nail addressed the council regarding the acquisition of a M44 Self Propelled Howitzer. The Howitzer will be placed in Ratz Park east of the Veteran's Memorial and this was approved by the city council in March 2012. Although the tank is free, Nail has estimated that it will cost between \$15,000 - \$17,000 to transport and set up the tank in the park. The VFW has already received a donation of \$5,000 from the Al Rahn family. It is the goal to have the tank in place by the November 11, 2023, Veteran's Day Service. Commander Nail is requesting that the city donate the concrete pad to set the tank on. Council Member Nevois stated that Nevois Construction Company would donate the labor for the concrete pad if the city will pay for the materials, estimated at \$3,000. The consensus of the council was in support of the VFW's efforts. This will be listed on the committee agenda for August 21st and possibly approved at a special council meeting the same evening.
