#### **ORDINANCE NO. 1536**

## AN ORDINANCE AMENDING TITLE XV, CHAPTER 153 OF THE CITY OF RED BUD CODE OF ORDINANCES 2021 PERTAINING TO HANDICAP PARKING

WHEREAS, certain areas of the City have handicap parking spaces designated in streetside parking areas; and

WHEREAS, a request has been made to designate a streetside handicap parking space on the south side of Randolph Street immediately West of the intersection with Madison Street; and

WHEREAS, the designation of streetside handicap parking areas needs to be formally stated in the Code of Ordinances; and

WHEREAS, the City finds that there is a need and that it would be in the best interests of the City to formally designate a handicap parking space on the south side of Randolph Street immediately West of the intersection with Madison Street.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

**SECTION 1:** That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

**SECTION 2**: That "Schedule F", Part VI of Title XV, Section 153-3(B) of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be amended by adding the following in alphabetical order, designating a handicap parking space:

Randolph St. (South)

From A point 80 feet West of Madison St. to a point 120 feet West of Madison St.

**SECTION 3**: This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

**SECTION 4**: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
