

ORDINANCE NO. 1546

**AN ORDINANCE AMENDING  
TITLE V, CHAPTER 51 OF THE CITY OF RED BUD  
CODE OF ORDINANCES 2021  
PERTAINING TO THE EMERGENCY SERVICES AND DISASTER AGENCY (ESDA)**

WHEREAS, the City of Red Bud has the power to appoint officers with the advice and consent of City Council; and

WHEREAS, it is no longer necessary to have a separate coordinator of the City ESDA; and;

WHEREAS, the City of Red Bud finds that these duties should be handled by the Chief of Police and that it is in the best interest of the City of Red Bud to formally revise the procedure.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

**SECTION 1:** That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

**SECTION 2:** That Section 51-2 of Chapter 51 of the Revised Code of Ordinances of the City of Red Bud is repealed and replaced with the following:

**51-2: COORDINATOR.** The duties of the Coordinator of the City ESDA shall be the responsibility of the Chief of Police. The Chief of Police shall be directly responsible for the organization, administration, training, and operation of the ESDA, subject to the direction and control of the Mayor, as provided by statute.

In the event of the absence, resignation, death, or inability to serve as the Coordinator, the Mayor, or any person designated by him shall be and act as Coordinator until the hiring of a new Chief of Police as provided in this Code.

**SECTION 3:** This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval, and signature by the Mayor.




