ORDINANCE NO. 1556

AN ORDINANCE AMENDING CHAPTER 71 OF THE REVISED CODE OF ORDINANCES PERTAINING TO WATER RATES AND SEWER RATES

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 71 which involves city utilities; and

WHEREAS, Chapter 71 of Title VII sets water rates and sewer rates for customers of the City of Red Bud; and

WHEREAS, the City of Red Bud has deemed it in the best interests of the City to amend the water rates and sewer rates for proper revenue and maintenance of the water system and sewer system for the benefit of the City and its customers.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

SECTION 1: That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

SECTION 2: That as of February 1, 2025, Section 71-11 of Title VII, Chapter 71 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

71-11: WATER RATES. For the following classifications of water service, the rates, based on the conditions and terms as set forth, are hereby established for the sale of water to the City’s customers unless otherwise agreed upon.

(A) Residential Rate - Inside Corporate Limits.

Customer Charge	\$7.00 per month, per meter
All 1,000 gallons used per month	\$6.20 per 1,000 Gallons

(B) Commercial Rate - Inside Corporate Limits.

Customer Charge	\$10.00 per month, per meter
All 1,000 gallons used per month	\$6.20 per 1,000 Gallons

(C) Out-Of-Town Rates. The rates for all customers located outside of the corporate limits of the City shall be one hundred twenty-five percent (125%) of the above rates.

SECTION 3: That as of February 1, 2026, Section 71-11 of Title VII, Chapter 71 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

71-11: WATER RATES. For the following classifications of water service, the rates, based on the conditions and terms as set forth, are hereby established for the sale of water to the City's customers unless otherwise agreed upon.

(A) Residential Rate - Inside Corporate Limits.

Customer Charge	\$8.00 per month, per meter
All 1,000 gallons used per month	\$8.00 per 1,000 Gallons

(B) Commercial Rate - Inside Corporate Limits.

Customer Charge	\$11.00 per month, per meter
All 1,000 gallons used per month	\$8.00 per 1,000 Gallons

(C) Out-Of-Town Rates. The rates for all customers located outside of the corporate limits of the City shall be one hundred twenty-five percent (125%) of the above rates.

SECTION 4: That as of February 1, 2025, Section 71-19 of Title VII, Chapter 71 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

71-19: BASIC USER RATE. There shall be and there is hereby established a minimum charge and a basic user rate for the use of and for service supplied by the wastewater facilities of the City as follows:

(A) A minimum charge of Eight Dollars and Eighteen Cents (\$8.18) per month shall be applied to all users whose water consumption does not exceed two thousand (2,000) gallons per month.

(B) A basic user rate of Four Dollars and Seventy-Two Cents (\$4.72) per one thousand (1,000) gallons shall be applied to all users for water consumption in excess of two thousand (2,000) gallons per month.

(C) All non-metered residential users of the wastewater facilities shall pay a minimum flat rate charge per month adequate to cover the costs of the minimum debt service charge and the basic user rate of Twenty-Two Dollars and Thirty-Four Cents (\$22.34) per five thousand (5,000) gallons. The flat rate charge will allow a maximum of five thousand (5,000) gallons per month.

In the event use of the wastewater facilities is determined by the City to be in excess of five thousand (5,000) gallons per month, the City may require such flat rate user to install metering devices on the water supply or sewer main to measure the amount of service supplied.

SECTION 5: This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.


