**ORDINANCE NO. 1517**

**SUPPLEMENTAL APPROPRIATION ORDINANCE**

WHEREAS, the City of Red Bud, Illinois approved its annual Appropriation Ordinance on May 2, 2022; and

WHEREAS, since the approval of the annual Appropriation Ordinance additional expenses beyond the appropriated amount have been identified; and

WHEREAS, no excess monies exist within the respective funds for a line item transfer; and

WHEREAS, the City has unappropriated cash reserves to cover the supplemental appropriations as well as future gas sold to customers; and

WHEREAS, 65 ILCS 5/8-2-9 allows the City to make supplemental appropriations during the fiscal year; and

WHEREAS, the City of Red Bud, Illinois, desires to appropriate said funds for its corporate purposes during the current fiscal year and finds such appropriation to be in the best interest of the City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

**SECTION 1:** That the following sums or so much thereof as may be authorized by law, and the same are hereby additionally appropriated for the corporate purposes of the City of Red Bud, Illinois, to defray all necessary expenses and liabilities of said City of Red Bud, as hereinafter specified, and for the fiscal year commencing on the 1st day of May, 2022 and ending on the 30th day of April, 2023, to wit:

**SECTION 2:** That said sums of monies are hereby appropriated from monies not previously appropriated in the annual Appropriation Ordinance, being surplus monies earned in the funds from previous fiscal years and identified after the passage of the annual Appropriation Ordinance.

**SECTION 3:** That the following sums or so much thereof as may be authorized by law, and the same are hereby additionally appropriated for the corporate purposes of the City of Red Bud, Illinois, to defray all necessary expenses and liabilities of said City of Red Bud, as hereinafter

specified, and for the fiscal year commencing on the 1st day of May, 2022 and ending on the 30th day of April, 2023, to wit:

**GAS FUND:**

**Fuel- Natural Gas**

**\$271,000.00**

**Line Item 03-4709-659.002**

**SECTION 4:** That said sums of monies are hereby appropriated from monies not previously appropriated in the annual Appropriation Ordinance, being surplus monies earned in the funds from previous fiscal years and identified after the passage of the annual Appropriation Ordinance as well as estimated additional revenues that will be received by the City from future gas sales to customers.

**SECTION 5:** This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

**SECTION 6:** This Ordinance shall be in full force and effect from and after its passage, approval, and signature by the Acting Mayor.
