ORDINANCE NO. 1521

AN ORDINANCE AMENDING TITLE III, CHAPTER 41 OF THE CITY OF RED BUD CODE OF ORDINANCES 2021 PERTAINING TO EMPLOYEE BENEFITS

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Title III which involves City Administration generally; and

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 41 which involves the Employee & Personnel Policy; and

WHEREAS, Chapter 41 includes employee life insurance and retirement award; and

WHEREAS, the City of Red Bud has deemed it in the best interests of the City to amend the employee life insurance and retirement award benefits.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

SECTION 1: That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

SECTION 2: That Section 41-8(A)(2) of Title III, Chapter 41 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

41-8: OTHER BENEFITS.

- (A) The City provides the following types of insurance for some or all of its employees:
 - (2) Life Insurance. A face value of Twenty Thousand Dollars (\$20,000.00) life insurance policy is paid by the City for all full-time employees. An optional policy for dependents is available to employee at their expense.

SECTION 3: That Section 41-8(F) of Title III, Chapter 41 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

41-8: OTHER BENEFITS.

(F) Retirement Award. Each full-time City employee and Department Head is eligible to receive a retirement award upon their retirement from the City, as defined herein and under terms and conditions defined herein.

- (1) Each full-time City employee and Department Head will be awarded a One Hundred Dollar (\$100.00) credit per completed year of service based on their anniversary hire date to be applied only to their retirement award and calculated only at the time they provide notice of retirement to the City.
- (2) The retiring employee will receive at their retirement a retirement award of their choice consisting of either (1) a coin(s) valued at an amount up to their awarded credit or as close as can be done in the sole discretion of the City; or (2) a monetary payment equal to their awarded credit. No cash payments will be made to an employee if the value of the coin(s) is less than their awarded credit. All withholding and taxes in accordance with State and Federal laws will apply.
- (3) For purposes of this Section, retirement is defined as (1) separation of employment from the City, completing at least fifteen (15) years of service with the City and participation in the Illinois Municipal Retirement Fund; or (2) separation of employment from the City, completing at least fifteen (15) years of service with the City and employee verifying intent not to work full time in the twelve (12) months after retirement from the City.
- (4) The retiring employee may be presented with their retirement award at a meeting of the City Council occurring within approximately thirty (30) days of their retirement date. If the retiring employee cannot attend such a meeting, then they shall receive their award from City Hall no later than sixty (60) days after their retirement date. Failure to claim the retirement award shall result in a forfeiture of said award.

SECTION 4: This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval, and signature by the Acting Mayor.
