ORDINANCE NO. 1513

**AN ORDINANCE AMENDING TITLE XV, CHAPTER 150
OF THE CITY OF RED BUD CODE OF ORDINANCES 2021
PERTAINING TO NON-ROAD INTERSECTION CROSSWALKS**

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 150 which involves traffic regulations; and

WHEREAS, Chapter 150-1 adopts Chapter 1 of the Illinois Vehicle Code, being 625 ILCS 5/1-100, *et seq.*; and

WHEREAS, 625 ILCS 5/1-113(b) provides that intersections may be designated at non-road intersections; and

WHEREAS, the City of Red Bud has deemed it in the best interests of the City to designate a non-road intersection crosswalk.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

SECTION 1: That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

SECTION 2: That Section 150-1 of Title XV, Chapter 150 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be amended by adding Schedule "W" as follows:

SCHEDULE "W"

CROSSWALKS- NON-ROAD INTERSECTION

In accordance with the provisions of Section 150-1 and 625 ILCS 5/1-113(b), the following non-road intersection crosswalks are hereby designated along with twenty (20) foot no parking zones on each side of the crosswalk boundary in accordance with 153-3(A)(2)(c), to-wit:

<u>STREET (Width of Crosswalk)</u>		<u>LOCATION OF CROSSWALK</u>
Locust Street (5 feet wide)	From	260 feet South of West line of Locust St. and W. Field Dr. intersection, then 5 feet wide to the South

SECTION 3: That Section 153-3(A)(2)(c) of Title XV, Chapter 153 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

(c) Within twenty (20) feet of a crosswalk at an intersection or designated crosswalk.

SECTION 4: This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.


