**ORDINANCE NO. 1504**

**AN ORDINANCE AMENDING TITLE III, CHAPTER 32  
OF THE CITY OF RED BUD CODE OF ORDINANCES 2021  
PERTAINING TO TERM OF CITY ATTORNEY**

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 32 which involves city officials, department heads, and employees; and

WHEREAS, Chapter 32 includes a subheading for the City Attorney which details the term, services, and duties of that city official; and

WHEREAS, the City of Red Bud has deemed it in the best interests of the City to amend the term of the City Attorney.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

**SECTION 1:** That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

**SECTION 2:** That Section 32-62 of Title III, Chapter 32 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

32-62: APPOINTMENT. The Mayor, with the advice and consent of the City Council, may appoint a City Attorney who shall be appointed at the first meeting in May of each year and serve a one (1) year term unless removed pursuant to Section 32-19 of this Code. The City Attorney may also be known as Corporation Counsel.

**SECTION 3:** This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.




