ORDINANCE NO. 1507

**AN ORDINANCE AMENDING TITLE V, CHAPTER 53
OF THE CITY OF RED BUD CODE OF ORDINANCES 2021
PERTAINING TO THE FIRE DEPARTMENT**

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 53 which involves the Fire Department; and

WHEREAS, Chapter 53 involves regulations of the operations of the fire department; and

WHEREAS, the City of Red Bud has deemed it in the best interests of the City to amend and update the regulations of the fire department.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

SECTION 1: That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

SECTION 2: That Section 53-3 of Title V, Chapter 53 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

53-3: OFFICERS. An officer must be an active member to be elected and the election is held at the first meeting in January of every year of Red Bud Fire Company No. 1.

Fire officers are: Chief, First Assistant, Second Assistant, Fire Captain, and 2 Lieutenants.

Board officers are: President, Vice President, Secretary, Treasurer, and Fire Marshal.

Company officers are: When the fire officers and the board officers act together as one managing body, they will be referred to as company officers.

SECTION 3: That Section 53-5 of Title V, Chapter 53 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

53-5: SUPERVISION OVER DEPARTMENT AND EQUIPMENT. It shall be the duty of the chief and his assistants to exercise control and supervision at all fires and events of the Fire Department. They shall be in charge of the care and maintenance of the

firehouse and all fire equipment of the Fire Department. The specific duties assigned to each Fire Officer is set out in the Bylaws of Red Bud Fire Company No. 1.

SECTION 4: That Section 53-9 of Title V, Chapter 53 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be repealed and replaced with the following:

53-9: AGREEMENT WITH RURAL FIRE COMPANY. Red Bud Fire Co. No. 1 and Red Bud Community Fire Company have a working relationship and an agreement to share in the expenses of operating the Fire Department. All fire units are housed in the same location. Red Bud Community Fire Company contributes money toward the purchase of new equipment and supplies for Red Bud Fire Co. No. 1. These actions are taken during joint meetings of Company Officers of Red Bud Fire Co. No. 1 and the Board of Directors of Red Bud Community Fire Company.

SECTION 5: This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.


