**ORDINANCE NO. 1508**

**AN ORDINANCE AMENDING TITLE VII, CHAPTER 71  
OF THE CITY OF RED BUD CODE OF ORDINANCES 2021  
PERTAINING TO UTILITY EASEMENTS**

WHEREAS, the City of Red Bud Code of Ordinances 2021 includes Chapter 71 which involves utility regulations; and

WHEREAS, Chapter 71, provides for general regulations relating to operation of the utilities; and

WHEREAS, the City of Red Bud, Illinois has determined that it is in the best interests of the City to change and update the utility regulations and specify regulations for utility easements; and

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RED BUD, ILLINOIS:

**SECTION 1:** That the above recitals are hereby made a part of this Ordinance as though written herein verbatim.

**SECTION 2:** That Section 71-9 of Title VII, Chapter 71 of the City of Red Bud Code of Ordinances 2021 of the City of Red Bud, Illinois be added as follows:

71-9: EASEMENTS. In return for the provision of utility services by the City, each Customer grants to the City an easement over, under, and across their property consisting of five (5) feet on both sides of each utility line for installation, metering, maintenance, repair, and replacement of each utility service. No Customer shall plant any bushes, shrubs, or other plants in any utility easement that would harm or interfere with the operation of the utilities. No Customer shall plant any tree, nor place or construct any structure in any utility easement, except that a fence may be constructed within the easement by permit but no closer than three (3) feet to any utility line. If any fence constructed in the utility easement needs to be removed for utility work at the sole discretion of the City, then any damage caused to the fence and cost of reinstallation shall solely be the cost of the property owner. The City's personnel shall have free access to and use the easements at any time.

**SECTION 3:** This Ordinance supersedes all Ordinances or parts of Ordinances adopted prior hereto that are in conflict herewith, to the extent of such conflict.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.


