### I. Ratz Park Renovation Projet Update

#### A. Swim Team – Use of Facilities

#### A. Additional Lighting for Multipurpose Field

#### C. Concrete Work

Nate Macarthy, Musket Athletic Director, said the area they want to concrete is the open grassy area behind the clubhouse and bleachers to make it accessible by ambulance. They are also looking at expanding/moving the Memorial. There is sufficient money in the FY'23 budget. Musket volunteers will do the labor.
