- A. My/Our failure to pay my/our utility bill as provided by the City Revised Code, paragraph 38-2-1 (E), (1) of the City Code;
- B. The City may surrender and Cash Account No. _____ and retain the principal to the extent such is needed to pay my/our delinquent utility bill(s);
- C. City shall release this assignment in writing upon the undersigned's cessation of City utility service or on or after 24 months from the date of this Assignment if requested to do so in writing by the assigner, or 24 months from the last date of default in payment of my/our utility bill, whichever first occurs provided all such services furnished by City to the undersigned have been paid in full at the cessation of utility services or at the time of Customer's written request to release the Assignment is made; if my/our utility account is being subsidized by a grant or assistance agency, I/we will not be eligible for an early refund of this Account; and
- D. Assigner understand and agrees that this assignment will not be released on or after the third annual anniversary of this Assignment if, prior to such time, Assigner has failed to timely pay Assigner's utility bill.
